I acknowledge and understand that the Girl Guides of Canada-Guides du Canada (GGC) Volunteer Screening Policy states that all Members must have a valid Police Reference Check (PRC). I also understand that certain Members may qualify to be exempt from submitting a PRC under very limited circumstances.

There are two types of PRC Exemptions:

- Renewable exemption – requesting an exemption for a 5-year period due to eligibilities listed.
- Permanent exemption – an exemption due to conditions that are not predicted to change such as: living in a nursing home, long-term illness, etc.

Members who **may** be eligible for a PRC exemption:

- **Do not** have contact with any girl Members.
- **Do not** hold any position within Guiding including Trefoil Guild or Link positions.
- **Unable**, at this time, to obtain a valid PRC (for example, Member is out of the country for an extended period of time, has a health circumstance that prevents participation or is in a nursing home).

I acknowledge that if my responsibilities change or if there is a significant chance that I will come into contact with girl Members (e.g. attend unit meetings, camps and/or events) I will be required to submit a PRC.

I understand that, if granted, a renewable exemption will be valid for the same time period deemed valid for a PRC as set by the National Board. Once the time period has expired I will be required to provide a PRC or re-apply for a renewal of the exemption. I further understand that if applying for an exemption renewal, I must continue to meet the eligibility requirements for exemption.

I understand that my PRC exemption may be communicated to Members of Guiding (including but not limited to advisers and Commissioners).
